Fall Community BBQ – November 14th from 11-2. Charlotte reviewed some of the final preparation items with the volunteers. SCPM will provide the hamburger, hot dogs, buns and grill.
SCPM Website – Bill made a motion to have Melissa investigate moving the Magnolia Lakes website to a new site. George seconded. All were in favor.
