#### **CALL TO ORDER:**

#### TREASURER'S REPORT:

February Expenses were \$3,372.10 February Deposits were \$11,575.00

Steve recommended moving the pool pump payment to be paid out of reserves. Everyone agreed. He will contact SCPM accounting.

Bill made a motion to accept the Treasurer's report as given. George seconded. All were in favor.

#### **ARC:**

There were 4 applications received. The ARC recommended all 4 for approval.

1134 WOC – exterior repainting

1140 WOC – landscaping

1180 WOC – widen the driveway

1177 WOC – add a fence provided it is six feet tall on all sides

Steve made a motion to accept the ARC Committee recommendations. Bill seconded. All were in favor.

## **GROUNDS AND LAKES:**

Charlotte reported that the City has repaired 3 sections of the sidewalk. She is still trying to get them to come out and repaint the yellow curb areas.

Charlotte also reported that there is an owner that supposedly has 8 dogs in the house. The neighbors have been instructed to call Animal Control and Code Enforcement if this presents a nuisance.

Fish Stocking – Steve made a motion to stock the three ponds with catfish per the FWC recommended rate at a cost of \$1,950.00. Bill seconded. All were in favor.

## **NEWSLETTER:**

Charlotte reported on the large number of cars that have been broken into recently. Bill will include this information in the next edition. He also photos to add from the yard sale. The next edition will be published in late April.

#### POOL:

Charlotte reported that there are some slats missing on the pool fence allowing people to enter without using the gate. Handyman, Carl Guettler, will be asked to replace them

## **WEBSITE:**

Nick submitted a report by e-mail. There were 2,328 page requests last month.

## **SCPM/VIOLATIONS**:

Sent 18 second/third / fourth letters

There are currently 17 cases open in the community.

The next drive will be on the 20th or 21st.

10 owners were sent a Certified Letter notifying them of suspension of pool use and other common areas.

#### Collections:

All 10 owners that are delinquent are either in mortgage foreclosure or with the attorney for collection.

The list is in your packets.

The attorney is proceeding with Association foreclosure on 1106 WOC and 1249 WOC.

2011 Assessment Notices were mailed to all owners on December 7, 2010.

Reminder letters were sent to 87 owners on 2/17. Late notices were sent to 47 owners on 3/4. 14-day demand letters were sent to 16 owners on 4/4. As of Friday, 13 owners have not paid. One is making payments.
