Peter made a motion to accept the Treasurer's report as given. Bill seconded. All were in favor.

ARC:

There was one application to replace a tree at 1109 WOC. The Committee recommended approval. Steve made a motion to approve the recommendation. Nick seconded. All were in favor.

GROUNDS AND LAKES:

Charlotte reported that the flowers have been changed out. The common areas will be mulched next week. The algae bloom in the lakes has been treated and Greg Kingery has provided a treatment schedule for the remainder of 2012. The "no swimming" sign has been replaced on the small lake. Bill has increased the lighting wattage on the islands and tightened the springs on the pool gate hinges.

NEWSLETTER: The next edition will be later on this month. We had a good turnout for the garage sale.

POOL: Peter reported that the pool is in good shape. There is a little black algae being worked on.

WEBSITE: Nick reported that there were 6,802 requests in April, 6,508 and so far 2,095 for May.

- 1. Fence replacement Mark provided two bids for new PVC fencing at a cost of just under \$4,000.00. This will be considered at a future meeting.
- 2. Signs Mark provided bids to replace the 4 signs at the pool and common areas. After discussion, Peter made a motion to replace the four signs with the same HDU material at a cost of approximately \$152.00 each. Steve seconded. All were in favor.
- 3. Pool furniture Peter provided costs on replacing some of the pool furniture. After discussion, Bill made a motion to purchase 6 replacement chaise lounges. Peter seconded. All were in favor.
