### **ARC:**

There were 2 new applications:

1350 Berryhill – install sun tunnel skylights - Approved

Nick made a motion to approve the ARC recommendations. Bill seconded. All were in favor.

1190 WOC – ext repaint body of house only - Steve made a motion to approve the re-painting of the body of this house. Nick seconded. All were in favor.

**GROUND AND LAKES:** Charlotte reported that the holiday decorations have been put up for the party.

**NEWSLETTER:** Bill requested photos of the upcoming events for the next newsletter.

**POOL:** Peter requested that the landscape company remove all the weeds inside the pool fence. Mark will contact Paradise.

Peter reported that the pool did not pass the last inspection because the depth markers are too faded. Dan is getting us a proposal to change them out to meet code.

Peter reported that he is getting quotes from Dan to relocate the back flush water line.

Restroom doors – Two bids were received. After discussion, Bill made a motion to accept the bid from Lowes for a cost not to exceed \$2,900.00.

New pool keys – This item was tabled again

**WEBSITE:** Nick reported that there were 8,123 requests in August, 8167 requests in September and so far 1,869 for October.

The new fence has been completed.

**OLD BUSINESS:**

1. New insurance carrier – Tower Hill is not renewing our policy. Steve is looking into going with a new agent for a new quote. The renewal date is the end of November.
2. Halloween party – budget – The party is scheduled for October 20<sup>th</sup> with a rain date of October 27<sup>th</sup>. Steve made a motion to amend the budget for the event to \$500.00. Peter seconded. All were in favor.
