CALL TO ORDER:

Charlotte Rose called the meeting to order at 7:00 p.m.

ROLL CALL:

APPROVAL OF MEETING MINUTES:

Peter made a motion to accept the BOD Meeting Minutes from February 12, 2013. Seconded by Steve and the motion was approved unanimously.

TREASURER'S REPORT:

Steve provided a Treasurer's report as of February 28, 2013:

February Expenses were \$2,492.36

Peter made a motion to accept the Treasurer's report. Marty seconded. All were in favor.

ARC:

There were 6 applications reviewed, 4 were recommended for approval:

1272 WOC – Driveway stain – Bombay – only the driveway

1129 WOC – Replace oak tree with palm tree

1175 WOC – Ext. paint

1370 Berryhill – replace tree

These 2 were not completely approved as submitted:

1380 Berryhill – Driveway and sidewalk stain – Bombay – only the driveway was approved, not the sidewalk. Job already complete.

1111 WOC – Driveway and sidewalk re-stain due to wear – Bombay – only the driveway was approved, not the sidewalk. This is a re-stain over existing / worn Bombay stain.

After discussion, Steve made a motion to approve the ARC recommendations. Nick seconded. All were in favor.

Steve then made a motion to approve the Bombay color stain on the sidewalks and apron of 1380 Berryhill and 1111 WOC. Peter seconded. All were in favor.

GROUNDS AND LAKES: Charlotte reported that new plants will be installed at the entrance next week. After discussion, Nick made a motion to approve an annual planting schedule for the front entrance plants for a cost not to exceed \$1,500.00. Bill seconded. All were in favor.

NEWSLETTER: Bill reported that the next edition will be published and distributed in early April.

POOL: Pool company is working on the items noted on the recent inspection. Mark has 2 bids for the landscape beds to be filled.

WEBSITE: Nick reported that there were 3,356 page requests in January and so far 975 page requests for February.

SCPM MANAGERS REPORT:

Since our last meeting:

We did a drive on 2/21.

Opened 1 new case.

Closed 2 cases.

Sent 2 second/ third / fourth letters

There are currently 6 cases open in the community.

Collections:

Annual dues notices were sent to all owners on 12/5/2012.

As of this morning, there are 19 owners delinquent.
