**GROUNDS AND LAKES:** Atlantic fence did the minor repairs to the fence.

outline of the information that will be included in each of the editions.

**POOL:** Peter reported that the pool is in good shape. The security lighting heads need to be replaced and the junction box for the pool light is rotted out. Steve made a motion to approve the funds for the repairs not to exceed \$500.00. Nick seconded. All were in favor.

**WEBSITE:** Nick reported that there were 8,646 page requests in May, 4,947 page requests in June and so far 1,182 page requests for July.

A Rent Demand letter was sent by the attorney on July 1, 2013

Steve made a motion to send 1157 WOC and 1175 WOC to the attorney for collections. Peter seconded. Charlotte, Nick, Marty, Adel, Peter and Steve voted yea. Chuck abstained. Motion carried. A Notice of Intent to Lien letter will be sent to both owners.
