#### **CALL TO ORDER:**

# **APPROVAL OF MEETING MINUTES:**

#### TREASURER'S REPORT:

Steve reported that he has started the process of moving the rest of the bank accounts to BB&T. The signature cards have been signed and he is trying to complete the transition by the end of May.

# **ARC:** 3 applications were reviewed.

2 of them were Not Approved because paint swatches were not yet put on the house for review.

1165 WOC – ext. paint – need paint swatches on the side of the house. 4668 Blackmore – ext. paint – need paint swatches on the side of the house.

Peter made a motion to accept the above ARC recommendations.

Steve seconded. All were in favor.

1174 WOC – Exterior paint colors. The ARC turned this one over to the Board for review. The Board reviewed the requested colors. After discussion, Mike made a motion to approve the colors. Peter seconded. Charlotte, Steve, Marty, Peter, Adel and Mike voted yea. Nick abstained. Motion carried. Bruce did not cast a vote since this is his property.

**GROUNDS AND LAKES:** Most of this was covered with Paradise prior to the meeting. Steve made a motion to add the Gambusia minnows to the ponds to help with mosquito control for a cost of \$1,000.00. Peter seconded. All were in favor.

1351 WOC sold at auction and the Attorney said that the Association will be paid in full for all dues and attorney fees. After that the bidder did not pay in full so it is not a closed case.

1151 WOC is with the attorney. No money was collected at the sale for the Association.

4600 Radford just went into Mortgage foreclosure last week

4 owners were sent to the Attorney for collections.

3 others are being researched.

One is an APO address.

## **OLD BUSINESS:**
