#### SCPM MANAGERS REPORT:

Opened 25 new cases. (Most of them driveways, sidewalks etc.)

Closed 32 cases.

Sent 38 second/third / fourth letters.

There are currently 23 cases open in the Community.

Hearing Notices were mailed to yet for 1223 and 1249 WOC.

1265 WOC repaired the fence / gate.

1169 WOC appears to be vacant and have ignored 6 letters.

1204, 1236 & 1238 have ignored multiple letters.

## Collections:

- 1. Landscaping bid for plants at the entrance After discussion, Mary made a motion to accept the revised bid from Paradise for a cost not to exceed \$2,500.00. Nick seconded. All were in favor. Charlotte will get the revised bid and compare the work and prices.
- 2. Pressure wash entrance sidewalks / clean and repaint the signs. The Board reviewed 2 bids. After discussion, Mary made a motion to accept the bids from Pro Line to do both jobs for \$1,160.00. Peter seconded. All were in favor.

## **NEW BUSINESS:**

- 1. Upcoming Events / Dates October 17<sup>th</sup> and December 5<sup>th</sup> are the days for the Community events this year.
- 2. Annual Meeting / Election October 13, 2015. The Second Notice with Ballots will be mailed to the owners next week. As of today there are 6 volunteers.
