Those homeowners who allow this road blockage to continue in front of their homes, will receive only one letter of warning before it becomes a legal issue.

Did you know there is a County ordinance prohibiting blocking the sidewalk in front of your house? There are many instances in which trucks, boats, business equipment and cars are parked across the sidewalks. A Brevard County officer may ticket you for being parked there. The sidewalks and streets belong to the County.

If you leave something large at the curb for trash pick-up (like carpet, appliances, furniture), it will not automatically be picked up on collection day. If it doesn't fit in your trash can, you must call Waste Management @ (321) 723-4455 to arrange for a separate pick-up.

IMPORTANT GROUNDS UPDATE

At the January meeting of the HOA Board of the Directors, a contractor discussed the possibility of upgrading our stormwater/lake system and the resulting erosion issues if we do not. The cost of this project is

extremely high. Nothing has been decided. More discussion is needed. Watch for updates.
